

### What happened, where and when?

On 6 February, a 7.8 magnitude earthquake hit southern Turkey near the northern border of Syria. Three Palestinian refugee camps in Syria were affected:

- 1. Al Nayrab
- 2. Handarat Camps in Aleppo
- 3. Al Raml Camp in Latika

Together with assisting a number of Palestinian communities in Syria's northern governorates, PRCS-S offered medical care and relief supplies to the affected families and supported the SARC teams in body recovery and rescue operations.

### **Scope and Scale**

The Palestinian refugee camps in Latakia (Alraml camp) and Aleppo (Neyrab & Handarat) were heavily impacted due to poor infrastructure. According to the preliminary field report dated 7 February, 26 buildings collapsed and 74 sustained significant damages.

A total of 351 people were injured, 4,000 people were displaced, and 39 people were confirmed dead.

While search and rescue efforts continue, the needs on the ground continue to increase. The situation is exacerbated by the extreme cold and the possibility of outbreaks.

# **Current National Society Actions**

Ten tents, nine with a capacity of 200–300 people and one with a capacity of 500–700 people, were erected in the Nayrab camp to house the affected

Shelter, Housing And Settle- ments	families. The tents offered accommodation for a total of 3,000 people.  The UNRWA classrooms and mosques were utilized by the affected individuals as temporary shelters, much like in the other affected camps.	
	PRCS has a strong presence in the various facilities and volunteer networks, and it is legitimately positioned to coordinate with authorities in general, and with the IFRC and SARC in particular, at many levels.	
Coordination	An initial situation assessment was undertaken and carried out in conjunction with SARC as part of the response. PRCS-S will collaborate with other actors on the ground, such as UNWRA, as needed.	
	The PRCS-S, mandated to support Palestinian refugee camps in Syria, mobilized emergency response teams to the affected areas, to provide critical emergency support such as emergency health and first aid, mental health and psychosocial support (MHPSS), shelter, relief, and food assistance.	
Health	A team of 141 volunteers from various fields including Disaster Risk Management (DRM) practitioners, Medical Care Services providers, and Emergency Medical Team (EMT), were mobilized in the camps, where the Earthquake struck to offer EMS and MHPS to the affected population.	
	A total number of 1,152 people, including children, received MHPSS, 335 received emergency medical care, and 42 received medical examinations and treatments at the medical point.	

# **Movement Partners Actions Related To The Current Event**

IFRC	The IFRC has launched two emergency appeals in response to the devastating 7.7 magnitude earthquake which has killed thousands of people and injured many more in the region.  This DREF request is complementing the efforts of SARC outlined in the emergency appeal to address the needs in Syria, and the IFRC office is making sure that there is coordination of activities.

### **Shelter Housing And Settlements**

Because the earthquake demolished community shelters and structures, there is an urgent need to offer appropriate sheltering assistance to people staying in tents provided by PRCS.

PRCS-S is sheltering 4,000 affected people and plans to set-up additional facilities (tents) to house up to 8,000 people.



### Health

PRCS-S aims to mobilize emergency medical teams to provide emergency First Aid, PSP, and basic health support to 2,500 people. Based on future assessments, PRCS-S may need to scale-up its health support as needed.



### **Livelihoods And Basic Needs**

The earthquake occurred during a particularly harsh winter, with some areas of the country experiencing sub-zero temperatures, at a time when people are facing severe power, fuel, and water shortages.

Those impacted have lost their fundamental means of subsistence and hence require food and household items (HHIs) as well as shelter support.

According to the PRCS-S rapid assessment, the earthquake affected 4,000 people in the Aleppo camps of Al Nayrab and Handarat, as well as the Latika camp of Al Raml. Those affected have lost their houses and belongings and are currently residing in large-scale tents set up by PRCS.

Through this DREF, PRCS-S will provide basic relief items including blankets, warm clothing, mattresses to a total of 8,000 people in the target refugees camps.

### **Operational Strategy**

#### Overall objective of the operation

The overall objective of this DREF operation is to support the Palestinian refugees in the affected areas of Latakia, Aleppo and Hama. In the initial phase supported by this DREF, a total of 2,500 people will receive support to cope with the effects of the earthquake through the provision of shelter, food, non-food items and assistance.

### **Operation strategy rationale**

The provision of required support to the affected communities, including, food, non-food items, and shelter.

### **Targeting Strategy**

#### Who will be targeted through this operation?

Through this DREF operation, PRCS-S will assist 2,500 Palestinian refugees in Latakia, Aleppo, and Hama, out of the 15,000 affected. The remainder of those affected are being assisted by various organizations on the ground, as well as PRCS in its later phases of operation.

#### Explain the selection criteria for the targeted population

PRCS-S will provide relief and shelter assistance to up to 2,500 affected and earthquake-displaced people in the camps. Additionally, PRCS has continued to provide medical treatment, relief items and shelter. The relief efforts will be carried out in coordination within the Red Cross Red Crescent Movement and relevant sectors.

### **About Support Services**

#### How many staff and volunteers will be involved in this operation. Briefly describe their role.

From the onset of the response, 400 PRCS staff and 141 volunteers have been mobilized. Medical personnel and emergency medical teams assisted by volunteers are among the staff members.

### If there is procurement, will it be done by National Society or IFRC?

Logistic support for the intervention will be provided in accordance with PRCS-S procedures to source and procure all needs and supplies, as well as to ensure effective and timely distribution to affected people.

#### How will this operation be monitored?

PRCS-S will deploy a reporting staff member from the headquarters to Syria to strengthen the capacity of the existing staff in the country. PRCS-S will produce periodic field reports to monitor the operation. IFRC in Syria will conduct monitoring visits as required.

#### Please briefly explain the National Societies communication strategy for this operation.

Regular updates on the operation will be disseminated to the partners. Furthermore, PRCS-S will produce communication materials to highlight response activities and give a voice to vulnerable and impacted populations, where possible, promoting human dignity as the guiding principle.
