To date, this Emergency Appeal, which seeks CHF 28 million, is 17 percent funded including soft pledges with a gap of CHF 23.5 million. Further funding contributions are needed to enable the Sri Lanka Red Cross Society (SLRCS), with the support of the IFRC, to help mitigate the current food insecurity brought about by the economic crisis and help people affected by the civil unrest in the country through integrated food security, nutrition, livelihoods, health, and education interventions targeting 500,000 people.

The Transition of Emergency Appeal to Unified Plan

The impact of the economic crisis is still high in Sri Lanka, various studies highlighted that the crisis is not going away anytime soon, it will become protracted, and people's situation will steadily deteriorate further over time. 6.3 million people in Sri Lanka are still facing moderate to severe acute food insecurity and their situation is expected to worsen in 2023 if adequate life-saving assistance and livelihood support is not provided. Therefore, it is crucial to provide continuous support to crisis-affected people in Sri Lanka.

This **operational update** is issued mainly to inform that the operation is to be extended until 31 December 2023, and will be incorporated into the Sri Lanka Country Unified Plan. A **standard 12-month report** of the appeal will be issued by 31 July 2023 to inform the progress of the operation until 6 June 2023. Onwards, the project code for the operation will be maintained, and reporting of the operation will be aligned with the bi-annual reporting of the unified plan of Sri Lanka. Additionally, a work plan for the operation until the end of 2023 will be available by the time the 12-month report is issued.

Description of the crisis

The current crisis in Sri Lanka is affecting all sectors of society and has created the conditions for increased vulnerability, poverty, and destitution among a significant proportion of the population. In October 2022, approximately 9.6 million people (42 percent of the total population) fell below the international poverty line for lower-middle-income countries. More than 60 percent of families are eating less, and eating cheaper, less nutritious food. This comes at a time when financial constraints have forced the government to scale back on nutrition programs, such as school meals and fortified food to mothers and undernourished children.

According to UN OCHA, an estimated 5.7 million people (26 percent of the population) or more are now in need of humanitarian assistance, with at least 4.9 million (22 percent) being food insecure¹.

Operational strategy

The operational strategy will remain the same by the time of this report, but it will be reviewed in the coming months to strategize the operational approach by reviewing the intervention and humanitarian situation in the country.

Summary of response

Since the onset of the crisis, the SLRCS has been monitoring the situation closely, mindful of its sensitivity and the safety of its staff and volunteers. The headquarters has maintained close communications with the branches to discuss options, preparedness, and contingencies. To ensure safer access and acceptance, the National Society will ensure its adherence to the Movement's Fundamental Principles.

As of 31 January 2023, SLRCS has been able to carry out the following activities to support the needs of the affected population, with the support of IFRC and its membership:

Cash and Voucher assistance



6,300 MPC grants disbursed to beneficiaries and **another 12,500 grants are in the pipeline** and currently being processed at SLRCS HQ and
Branches

Health



Around 21,600 people were provided with health assistance and over 1,000 people were transported to hospitals. Two high-performance tents were procured and used. A consignment worth CHF 100,000 of essential medicines and medical consumables was handed over to the Ministry of Health, 625 volunteers trained on PFA in all 25 branches

Education



15,875 school kits (stationery, school bags) procured and distributed. Another 5,000 are in the pipeline and currently being processed at SLRCS HQ and Branches. Identified schools for feeding programme to support 15,000 children for three months.

Challenges

- The implementation is behind the Plan of Action (PoA) due to many reasons but one of them being limited human resources at SLRCS with high turnover.
- On-going economic crisis in the country which led to procurement delays and delivery of items due to shortage of fuel, limitation on availability of items, inflation.
- The country faced severe floods in August and September 2022 that affected 10 districts in Sri Lanka that also delayed the complex emergency interventions.
- Due to uncertainty of funding, the scope of work had to be changed numerous times which also led to the delay in the implementation of the activities.

Next Steps

A review is being planned to be carried out during the month of May 2023 to inform the operation strategy forward, and to evaluate what has been done, the effectiveness and assess the operations and humanitarian landscape in the country after one year of implementation of EA. Based on the review, the operational strategy will be revised, plan of action will be developed and will be included in the 12-month report.
