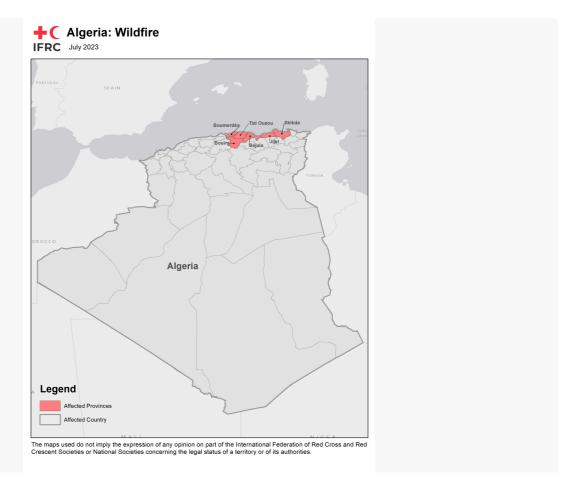

Description of the Event

What happened, where and when?

Around 35 wildfires have been rapidly spreading across the northeastern region of Algeria in more than 11 regions since July 24th, causing extensive devastation. The disaster had a profound impact on 6,000 families, with the Algerian Government reporting 34 confirmed deaths. The affected population heavily relies on crops and livestock, both of which have been severely impacted by the wildfires, resulting in further hardships for the communities. Many homes have been reduced to ashes, leaving families displaced and vulnerable. The dire situation has also affected the health of the population, as the flames and smoke have led to thousands of injuries. The magnitude of the disaster requires urgent attention and support to address the immediate needs of those affected. However, the prevailing weather conditions remain a cause for concern. With temperatures exceeding 45 degrees Celsius and wind speeds exceeding 50 km/h on the Tunisian borders, coupled with low humidity, the conditions were suitable for the expansion and intensification of the wildfires.

Amidst this dire situation, the National Society had been actively engaged in response efforts for several months, successfully completing a significant portion of the distribution operations. Understanding the evolving needs, the National Society had formally requested critical changes from the International Federation of Red Cross and Red Crescent Societies (IFRC), aligning with the adjustments previously outlined.

Scope and Scale

Algeria had been exposed to heat waves for over 60 days, with extreme weather patterns with temperatures exceeding 45°C in June and 50°C in July. The country was expected to witness local fires because of the weather conditions and the severe summer season. Additional factors have turned local fires into uncontrollable wildfires in the 3rd week of July.

The wildfires have reached several wilayas of the northeast, the most affected being: Bejaïa, Skikda, Tizi ouzou, Bouira, Jijel, Boumerdes. A total of 30,000 people were affected by the wildfires. So far, at least 34 deaths have been registered by the Algerian government and more than 700 people have been injured.

Homes, livestock, and crops were heavily affected, which directly impacted the well-being of the population, elderly people, and children. The national society was one of the first responders to the event, deploying its teams to conduct assessments of the magnitude of the effects of this event.

A total of 3,880 people were provided shelter in the evacuation centers while the rest of the people were provided with tents by the national society or decided to relocate to stay with relatives. The fires had a significant impact on the livelihoods of the impacted population.

Shelter Housing And Settlements

A large number of people were forced to leave their houses (170 families by the second day in Jijel, Bouira, and Bejaia) due to the fires, and the number of tents in stock is very limited compared to the gravity of the disaster, and the schools prepared as shelters were getting filled quickly. At the time of submitting this request, 3,880 people were very sheltered in the temporary shelters provided by the national authorities, while others were either staying in tents provided by the national society or had relocated to stay with relatives. These people had lost their shelters and their shelter items and need basic household items such as mattresses and blankets among other needs.



Livelihoods And Basic Needs

The majority of affected people live off crops and livestock that were affected by the wildfires (9 chicken coops with the capacity of 1000 chickens each, 22 lambs, and 35 family-owned agricultural lands were reported to have burned down in Jijel based on initial assessments)



Health

The immediate risk to life and physical health: injuries (severe burn injuries), respiratory issues including asthma, chronic obstructive pulmonary disease (COPD), and casualties, leading to an increased demand for emergency medical services.

Many affected people experience post-traumatic stress disorder (PTSD) and other mental health issues.

Overwhelmed healthcare facilities and disruption of health services, as well as strain on medical supplies and resources (shortages in essential items)

The displacement of people and overcrowded living conditions in temporary shelters can facilitate the spread of infectious diseases. These needs were not addressed under this operation but were covered by the national authorities with the support of the national society.



Water, Sanitation And Hygiene

The fires have caused infrastructure damage to water and sewage system networks. Rehabilitation of these networks will be carried out by the national authorities. Immediate need for drinking water and WASH facilities remains urgent needs for the people who lost their households to the fires. Due to the nature of temporary shelters, it is expected that some hygiene and health issues may arise due to crowdedness.

Operational Strategy

Overall objective of the operation

The DREF operation aimed to meet the immediate needs and to support 19,500 people affected by the wildfires in Bejaia, Bouira, Tizi Ouzou, Jijel, Skikda, Boumerdes, through the provision of Household items, Water and hygiene kits and food parcels.



Operation strategy rationale

To achieve the objective of the operation, the national society aimed to provide 3,900 families (19,500 people) with food parcels, and 3,750 families with WASH services including water and hygiene kits to cover their needs for 3 months. In addition to replenishing 2,000 mattresses, and 2,000 blankets that were distributed to the families that lost their households to the fires. The national authorities were working on addressing the long-term needs of the affected population. The national society planned to provide 50 tents as a temporary shelter to the families who lost their homes to the fires and were residing in remote areas that do not have official shelters prepared by the authorities.

The IFRC received a request from the NS to authorize pivotal adjustments in procurement procedures, aiming at effectively aiding those in dire need and restocking essential supplies. These modifications encompassed two crucial areas of assistance provision.

Initially, alterations were enacted in the composition of food parcels, strategically substituting beans and lentils with pasta and rice due to the unavailability of the former items in the market. This proactive adjustment ensured the continued provision of sustenance to beneficiaries despite logistical challenges in sourcing specific food items.

Simultaneously, there was a concerted effort to refine the contents of hygiene kits. The initial components, encompassing shampoo, shower gel, and towels, were broadened to include a more comprehensive array of additional hygiene products. This expansion aimed to enhance personal hygiene practices among recipients and better equip them to combat health risks prevalent in their circumstances.

Furthermore, a deliberate escalation in the quantity of distributed water to the affected population was initiated, acknowledging the critical importance of access to clean water in mitigating various health challenges faced by the community.

In light of these multifaceted adjustments and the urgency to acquire necessary responses, a formal request was made to extend the operational timeframe by an extra month. This extension was deemed imperative to facilitate timely responses from the IFRC, complete the required reporting, and ensure the successful closure of the ongoing operation.

Targeting Strategy

Who was targeted by this operation?

This operation targets the population affected by the wildfires in the mentioned most affected 6 wilayas (Bejaia, Bouira, Tizi Ouzou, Jijel, Skikda, Boumerdes). With a focus on families whose households were completely destroyed and were either residing in the shelters prepared by the authorities or in tents provided by the national society until they were relocated to permanent shelters.

Explain the selection criteria for the targeted population

The operation attempted to target all of the population affected by the fires, taking into consideration the prioritization of the people most in need, including:

- Families who have their households completely or partially damaged by the fires.
- Families who have lost their livelihoods and were in need of immediate food and water support
- Female headed households
- Families with people with disabilities, elderly people, and injured people due to the fires.

| Delays and/or challenges in procurement | A procurement surge profile will be deployed under this operation to provide support and guidance to the national society on procurement procedures and alternatives in case of challenges. IFRC MENA RO procurement department will continue to provide the support needed to the national society throughout this operation. Local procurement will be conducted through the national society to avoid delays with the option of conducting international procurement if local procurement becomes a challenge. |
| Risk to the safety of volunteers due to hot weather | The volunteers are provided with awareness raising messages on how to prevent the possible implications of the heatwaves. They are also provided with water and caps (as part of their uniforms) and are working in shifts to avoid exhaustion. |
| Access to the affected areas can be challenging | The national society is continuously coordinating with the national authorities on safety and access to the affected areas. |
| Reoccurrence of wildfires due to the continuing heatwaves | IFRC MENA RO continues to monitor the forecasts and share relevant information and alerts with the national society. The national society keeps close communication with the national authorities and national MET agency for relevant information or alerts on weather conditions. The national society is also working on replenishing some of the items used during their response as part of their restocking activities in case they need to respond to an upcoming event. The national society and the national authorities have also been working on spreading awareness messages on what to do in case of fires. |

Narrative description of achievements

- 2000 mattresses were distributed to 2000 persons affected by the wildfires.
- 2000 blankets were distributed to 2000 persons affected by the wildfires.
- 50 tents were distributed to host the displaced because of the wildfires.
- Procurement for blankets was made in January to replenish the ARC stocks.

Lessons Learnt

- Adequate distribution of relief items such as mattresses, blankets, and tents to meet the immediate needs of individuals affected by wildfires.
- Importance of timely procurement to replenish stocks of essential items like blankets, ensuring preparedness for future disasters.
- Efficient logistics planning and management to ensure smooth distribution of relief items to affected populations.
- Addressing the immediate shelter needs of displaced individuals through the provision of tents.
- Recognizing the critical role of pre-positioned stocks in disaster preparedness and response efforts.

Challenges

• Distribution lists containing the names of persons receiving blankets and mattresses are impossible to obtain.

Narrative description of achievements

- The food parcels were distributed according to the agreed planning; 19,500 individuals benefited from food parcels for 3 months.
- A purchase was made in December for food parcels to replenish the stocks.

Narrative description of achievements

- Hygiene kits were distributed to the families for a period of three months.
- Drinking water was distributed to the families that benefited from it for three months following the disaster.
- A procurement was made in January 2024 regarding these items in order to replenish the stocks of ARC.

Lessons Learnt

- •While distributing hygiene kits and drinking water immediately after a disaster is crucial, ensuring that these provisions continue for an extended period of three months highlights the importance of sustained support for affected communities.
- Reflecting on the effectiveness of the aid provided over the three months can inform future strategies. It's essential to continuously evaluate the impact of assistance and adapt interventions based on feedback from the affected communities.
- Following the IFRC procedures in terms of procurement allows the National Society to follow up with the financial reporting and to submit the correct supporting documents in time.

Challenges

Narrative description of achievements

On January 29, 2024, a workshop was held at the National Training Center of the Algerian Red Crescent to discuss lessons learned from emergency humanitarian response operations through the Disaster Relief Emergency Fund (DREF) carried out by the Algerian Red Crescent in response to wildfires.

The workshop was attended by volunteers from various Algerian provinces that have recently been significantly affected by wildfires, recurring disasters in recent years.

The workshop was opened by the Programs Coordinator at the Algerian Red Crescent and the workshop supervisor, where the Red Crescent movement and its seven principles were introduced.

The supervisor then proceeded to present the workshop content as agreed upon earlier with Dr. Farah and Mr. Ahmed, based on the document sent by them.

Through interactive workshop presentations and purposeful exercises using brainstorming and SWAT analysis on the intervention methods carried out by Algerian Red Crescent volunteers during the wildfires, important lessons were derived.

Key takeaways from the workshop include:

- Identifying weaknesses accurately.
- Understanding how to deal with current and unexpected points during the disaster.
- Clarifying strengths and available opportunities for investment in optimal preparation and reducing future anticipated risks.
- Drafting common good practices for provinces frequently affected by wildfires.
- Proposing periodic training camps (3 annually) to enhance volunteers' capabilities and teach them effective and successful disaster intervention practices.

After 9 hours of work, including 3 breaks (2 tea breaks and 1 lunch break), the workshop concluded.

- The volunteers perdiems were distributed.
- A dref training for 20 persons from the NS HQ and branches was made for the period of three days.

Lessons Learnt

- Accurate identification of weaknesses in emergency humanitarian response operations.
- Learning to effectively handle current and unexpected challenges during disasters.
- Clarification of strengths and available opportunities for better preparation and risk reduction in future disasters.
- Development of common good practices tailored for provinces frequently affected by wildfires.
- Proposal for periodic training camps (3 annually) to enhance volunteer capabilities and impart effective disaster intervention practices.

Challenges

•Lack of a clear memo that describes the amounts of perdiems given to each volunteer.
