
Figure 1: ERCS volunteers mobilized other local volunteers to support emergency shelter construction to relocate people affected by landslide in Gofa. Photo credit, ERCS zonal branch.

A. SITUATION ANALYSIS

1. Description of the crisis

Since July 2024, heavy rains, landslides, and flooding in Ethiopia affected over 500,000 people across 14 zones, displacing more than 140,000 and claimed lives of about 420 people across the 7 regions. Oromia, Sidama, Amhara, Tigray, Gambella, Central, Southwestern and Southern regions suffered severe damage, with more than 8,659 hectares of cropland lost, 113 livestock dead, and 277 houses destroyed. Gofa, Desnech Woreda, Omorate Town, and multiple zones were identified at high risk of landslide, forcing the relocation of communities to a newer identified area. Since then, ERCS and other humanitarian actors have been actively providing humanitarian support to the affected people. ERCS with the support from IFRC launched an appeal, **Ethiopia - Landslides and Floods** (MDRET036); with the funding ask of 6 million preceded with an operation update **Ethiopia - Landslides and Floods** (MDRET036) to increase scope, scale and time of operation from 1 year to 18 months.

The response is designed to support the affected communities with transitional shelter and household materials, food security and livelihood recovery through MPCT, farm inputs and skill training for youth, WASH, health, strengthening community disaster risk reduction while mainstreaming protection, gender and inclusion and ensuring communities have full ownership of the program for sustainability.




2. Summary of response

The response strategy remained the same, however the geographical targeting has been updated to meet the affected 7 regions from the original planned 2 covering Oromia, Sidama, Amhara, Tigray, Gambella, Central, Southwestern and Southern regions affected by landslide and floods, with multisectoral approach. The target

population has increased from beneficiaries 25,500 to 55,712, representing approximately 15% of the affected population. However, due to the enormous increase in the number of affected population, and increased vulnerabilities, with limited resources, ERCS has provided emergence support to cover the 6 regions, and has intensified the recovery to 3 regions, Southern region, Central region and Oromia regions which have severe impacts and less support from other partners.

Currently the Appeal is 55% funded with the funding from multiple donors including RCRC and non-movement partners, with bilateral and multilateral support. This is an added value to the NS being the partner of choice in emergency response in the country. Currently the operation has reached 53,527 People with Shelter, Health, WASH, MPCT and PGI.

Shelter

Since the disaster occurrence, communities have been living in temporary settlements while the transition shelters are under construction in the new allocated site. ERCS has reached more than 31,500 people (6300HH) with household items, and emergency shelter materials in Southern, Central, Southwest and Oromia regions. The support came from ERCS own stock, 4 Zonal Branch, GRC and IFRC support. Through the incident coordination it was decided to relocate people residing in the most risk areas. New sites were identified and the Cluster agreed to construct semi-permanent shelters.

Currently, a total of 462 transitional shelters are constructed. With government support, 110 houses were constructed, and distributed to the needlest families and an additional 80 houses are under construction with the support from Habitat NGO.

Under this appeal, ERCS committed to constructing 352 houses with latrines, 310 in Gofa zone and 42 houses in Silte zone. Currently, in Gofa more than 271 houses have been constructed with contribution from multiple partners. (185 with support of IFRC and 86 with support of IFRC and The Church of Jesus Christ later day's saints). The approach deployed was to procure all materials and subcontract Construction Company. All materials were procured by ERCS through 2 different tenders, Industrial materials, processed at HQ, and local materials processed at branch level, including the labour, with support from ERCS HQ logistics, and approved by IFRC regional logistics. The regional government is coordinating the construction of shelter for the affected people in Geze Gofa woreda, Gofa Zone.

The approach deployed was to procure all materials and subcontract Construction Company. All materials were procured by ERCS through 2 different tenders, Industrial materials, processed at HQ, and local materials processed at branch level, including the labour, with support from ERCS HQ logistics, and approved by IFRC regional logistics. ERCS also constructed a warehouse at the site for material storage, and the woreda government has provided a warehouse at woreda level where all industrial materials are stored. The regional government is coordinating the construction of shelter for the affected people in Geze Gofa woreda, Gofa Zone.

The ERCS planned houses will benefit at least 1860 people. The construction has engaged number of community members, and 10 volunteers who were trained and deployed to support supervision and quality assurance. 1 shelter engineer has been recruited, and 1 shelter surge was deployed for 3 months. The surge played an important role in supporting site assessment, landscaping, quality shelter designing, BOQ development and development of the construction plan. The community has established the construction committee to coordinate local material delivery on site, and community participation 3 days per week, to support with material movement and any required labour work.

Currently the construction process has faced several challenges, including unforeseen cost for material movement from the main warehouse provided by Government to the small warehouse on site, where the big trucks cannot reach, thus the team is required to hire small trucks capable of going up-hill. The area has no passable roads to all the construction areas; thus, the casual labour is required to move materials closer to the site, which were not planned before. The BOQ did not include flooring materials (stones/grave sand) to fill in the houses. However, the cement available is enough for flooring. These challenges were discussed jointly by the ERCS field staff, HQ and IFRC during supervision, where the team agreed to review the budget and allocate some cost to accomplish the construction from unused budget lines or lines with balances.

Food Security and Livelihoods

It was clear from the assessment conducted by Government, ERCS and UN agencies that the affected communities were predisposed to food insecurity due to displacement and damaged livelihoods sources. Most of the affected population depended on small-scale farming and with damage to their planted crops and their farms, these families would be exposed to food insecurity. This has deprived the affected population of their main source of food and income, especially displaced HH living in temporary shelters or relocated to new living sites. ERCS scaled up the planned interventions under food security and livelihoods, to the 29,690 affected communities with emergency food and nutritional supplements to malnourished children.

ERCS with IFRC and Bilateral support from GRC and Coca-Cola foundation supported 627(MHH 458 & FHH 169) relocated families with the Multipurpose cash for 3 rounds (2 GRC, 1 Coca cola foundation). This support

complemented the first round provided by SNN local NGO. All cash support has been well coordinated by the government, under the incident command point.

ERCS has also planned to provide Farm inputs (seed and fertilizer) for 2727 HH, including the 627 HH displaced in Gofa. Currently Agricultural farm inputs which include improved seed **54qt (Maize and Haricot bean)** and **314qt (DAP & UREA)** procured and distributed for 627 HH **(MHH 458 & FHH 169)**. More 2100 HH will be reached in the next round.

A total of 30(25M & 5F) volunteers and community members have been trained to conduct mentorship to affected HH to diversify their livelihood options and regain their livelihoods. Basic business skill development training for 50(M=25 F=25) Youths has been carried out and all trainees are engaged in developing their business plan to provide startup kits to revive their livelihood.

Health

Health facilities in the affected areas are partially functioning, inaccessible and overwhelmed due to the impacts of floods and landslides. The affected areas are also prone to cholera measles and Malaria to waterborne diseases due to damaged water sources. Furthermore, the affected community is impacted psychologically, pushing ERCS and other partners to continue providing psychosocial interventions.

In this response, ERCS engaged with its full capacity on search and rescue, a total of 4658 people rescued from incidences in all regions and 280 supported in safe and dignified burial. Health cluster jointly with ERCS zone and woreda health offices organized health campaign advocating the prevention and control of disease and promoting hygiene and sanitation in the villages, urban town and market area, addressing about 70,000 people in 7 key areas. A total of 30 (M=25 & F=5) volunteers and woreda health staff trained in MPHPSS. and 20 (M=20 & F=5) were deployed to provide house to house psychosocial support, case identification and awareness education. Up to this reporting period, 154 HH (770 people) within the affected areas are reached through home visit and consultation. Emergency medical services, health promotion and support in ambulance operations are going on to the affected families and the entire Gofa society.

Water, Sanitation, and Hygiene

The floods and landslides destroyed water and sanitation facilities in the affected areas, posing displaced population at risk of water-borne diseases. The government, through it WASH cluster and ERCS with support from Arba Minch University conducted prior water assessment to verify water quality. Following this, ERCS, with the support of GRC, established 2 water reservoirs and 9 water points to access quality clean water in the new village through this appeal. A total of 32 (7F 25M) WASH committee members were trained and supported with water source repair materials to ensure the management of water schemes and efficient distribution of water. The HH were also supported with water treatment chemicals, to cover a period of 3 months.

The NS has provided 5,777 HH with essential WASH supplies (WASH NFI and hygiene kits) comprising of 20 lt Jerrican, Washing dish, body soap, laundry soap. A total of 30 volunteers were trained in WASH and Hygiene promotion, jointly with Government representatives conducted 14 health and Hygiene campaigns, distributed 1200 printed key messages and reached more than 8700 people in Gofa.

Protection, Gender, and Inclusion (PGI) and CEA

The displacement has increased protection concerns in different areas, and heightened risk of sexual and gender-based violence (SGBV) and child protection concerns. ERCS with IFRC conducted PGI risk assessment in Gofa and

provided capacity development for 25 volunteer and field staffs based on the needs. Following the training volunteers deployed in awareness raising, community dialogue and conversation with affected communities. Women participation has been encouraged to bring out the socio-cultural norms often hindering them from speaking out, decision-making and increasing the risk of discrimination. The solution to the barriers is jointly agreed among the male and female group dialogue.

Community targeting promoted to consider the most vulnerable groups among the affected community through community engagement mechanisms identified. Community compliant, feedback and support mechanism is established to ensure service provisions are in line with quality assurances and transparency and address challenges faced by communities. However, there is a need to strengthen the committee through orientation to enable documentation, monitoring and reporting issues.

3. Operational risk assessment

The operational risk constraints remain the same with additional of **increased disasters with scarce resources and security concerns**, since some of the affected areas have active conflict, which may hinder the humanitarian access. However, the ERCS has strong relation and acceptability in the country, with network of branches and volunteers. Additionally, active security measures will be activated in case the team will be moving to these conflict areas. IFRC supported in conducting security assessment jointly with ERCS, however, they continue with situation monitoring and sharing updates frequently. Upcoming rain season also impact the construction process and is much more risk to people leaving in the temporary shelters.

B. OPERATIONAL STRATEGY

Update on the strategy

The operation <u>Ethiopia - Landslides and Floods (MDRET036)</u> remain the same, and the NS has transitioned the emergency response to the recovery, mainly targeting the most affected less supported regions, Oromia, Centra and southern regions.

- In all affected areas ERCS participated in the evacuation of the displaced people and relocating the most vulnerable to the safer places. The majority are hosted in collective sites in public buildings and makeshift within the host community.
- Distribution of Shelter materials has been extended to plastic sheets, ropes and HH items comprised of blankets, nets, and kitchen sets, from the prepositioned stock, replenished by IFRC and the support from NS humanitarian response fund and the GRC.

- In the southern region, Gofa zone, the Government has cleared and allocated the new land to evacuate displaced people residing in schools for the schools to resumption.
- The woreda administrators in collaboration with partners are coordinating the construction of Transition shelters with the close support from the country and Global Shelter cluster and have provided ERCS with a warehouse for industrial material storage at woreda level.
- IFRC Surge shelter coordinator in collaboration with ERCS shelter engineer conducted surveys to determine the specific shelter needs and designed shelter structures based on the government guide and developed the actual BOQ.
- Procurement of materials was conducted by ERCS HQ for industrial materials, and Southern region branch for Local materials, with approval from IFRC regional logistics.
- On job training on safe shelter construction has been provided to the community construction committee and 10 volunteers in Gofa construction site that has contributed to mobilization of quality local material (sand, stone, woods) and assuring the quality of shelter construction through regular monitoring and supervision.

- Community engagement has been very key in supporting the materials movement, where the construction committee has organized 3 days per week for community support. The shelter engineer will quantify the community support, for accountability.
- A total of 271 out of 310 planned houses have been constructed are at the finishing stage with contribution from multiple partners. (185 with support of IFRC and 86 with support of IFRC and The Church of Jesus Christ later day's saints). This will contribute to 110 houses being built by the government, 80 under

construction from Habitat NGO, leaving the gap of 166 for the targeted 627 HH relocated.

 ERCS has also started the construction process of 42 houses in Silte zone, Central Ethiopia region through bid process to mobilize local materials and labour for construction, while the factory construction materials re already procured from HQ and have started to be transported to the construction site.

- Completion of plastering the shelters, toilet structures and budget review to cover the flooring costs.
- Documentation of the shelter construction process
- Engaging with Government for beneficiary identification and Shelter Handling event.




