Democratic People's Republic of Korea: Floods

The International Federation of Red Cross and Red Crescent (IFRC) Disaster Relief Emergency Fund (DREF) is a source of un-earmarked money created by the Federation in 1985 to ensure that immediate financial support is available for Red Cross Red Crescent response to emergencies. The DREF is a vital part of the International Federation's disaster response system and increases the ability of National Societies to respond to disasters.

Summary: CHF 378,714 was allocated from the IFRC's Disaster Relief Emergency Fund (DREF) on 27 August 2010 to support the Democratic People's Republic of Korea (DPRK) Red Cross in delivering immediate assistance to some 16,000 beneficiaries and to replenish 2,500 family disaster preparedness stocks.

DPRK Red Cross, with the support from IFRC, responded to the floods in Sinuiju city, north Phyongan province, which was severely affected by flash floods on 21 August 2010. The DPRK Red Cross Society immediately distributed relief items from its disaster preparedness stocks to 2,500 affected families. Items included tarpaulins, blankets, cooking sets, jerry cans, water purification tablets and 1,500 family hygiene kits. Approximately

6.71 million litres of drinking water was distributed by the Red Cross water treatment plants to evacuees, health institutions and public service facilities in the flood affected area. It was the first deployment by DPRK Red Cross of the water treatment unit in response to a disaster, since the equipment was donated from the Spanish and Swedish Red Cross and personnel trained in 2009 and 2010. Over 350 Red Cross volunteers were mobilized for evacuation, rescue, first aid, distribution of emergency relief items and hygiene promotion among communities, in close cooperation and coordination with local authorities and other public organizations. With the support of DREF, disaster preparedness items for 2,500 families released for the floods response were replenished in the Sinuiju regional disaster preparedness warehouse.

The procurement of replacement parts and consumables under the water and sanitation is in process. While the order was made within the operation timeframe, delayed delivery resulted in the operation's inability to book the expenditures earlier. The total cost of this procurement is approximately CHF 9,000.

The operation is complete and this narrative is final in terms of activities carried out; a final report with final financials will be published by 30 June 2011. An estimated CHF 70,000 is expected to be returned to DREF at the end of this operation.

The European Commission's Humanitarian Aid and Civil Protection department (DG ECHO) as well as Netherlands Red Cross/ Netherlands government made contributions towards the replenishment of the DREF for the allocation made to this operation.

The situation

Rivers in northeast China were inundated by downpours between 19 and 20 August, causing severe flooding and damage to Sinuiju city, a border town with China, in the northwestern area of the Democratic People's Republic of Korea (DPRK). From the Aihe river in China, an estimated 5,300 cubic metres of water flooded into the Amnok river per second and water levels began to rise suddenly from midnight on 21 August. The Amnok river reached its highest water level since 1995, when the country was affected by its worst flooding in decades. The flash floods submerged Sangdan, Hadan and Taji-ris in Sinuiju city and Soho, Ojok and Maksa islands in Uiju city.

According to official government information, 7,139 dwelling houses were totally or partially destroyed, and over 7,200 hectares of farmland were affected by flash floods. The main water pumping station, including the treatment plant, was completely inundated and some parts of the main water supply pipe (900mm) were washed away, resulting in the disruption of water supply to 350,000 citizens of Sinuiju city.

According to local authorities, a total of 23,651 people from severely flooded area were displaced and moved to safer locations. In Sinuiju city alone, 16,640 people were displaced and lived in 11 school buildings temporarily.

The government, together with local donations, provided the displaced communities with emergency food, clothes, bedclothes and cooking equipment. Hospital doctors and nurses visited camps and evacuees staying in schools twice a day to provide on-the-spot treatment and to give medical advice to patients. Most of the destroyed buildings and infrastructure like clinics, kindergartens and nurseries were re-built or rehabilitated within 40 days by the government.

Coordination and partnerships

The DPRK Red Cross national disaster response team (NDRT) coordinated its actions with the national flood damage response committee, an *ad hoc* government coordination body. The National Society also shares and advises the national disaster coordination committee (NDCC) on all programme and emergency response activities undertaken with IFRC's DPRK country office.

On 23 August, all in-country non-governmental organizations, through the Inter-Agency Contingency Planning Working Group (IACPWG), met to discuss and propose a plan of action to address the flooding in northwest DPRK, for sharing with the DPRK government. On 26 and 27 August, the government organized a combined UN mission field visit by train to Sinuiju, where an assessment was undertaken, covering the affected population. Coordination have been continued between all international and government organizations.

Red Cross Red Crescent action

In view of the flooding season, all provincial Red Cross branches were alerted from July to prepare for possible floods in the rainy season, preparing the emergency liaison volunteer network for early warnings, evacuation routes as well as evacuation simulations in disaster-prone areas.

In close contact with the national flood damage response committee, DPRK Red Cross activated its emergency preparedness and response task force and operated the pre-warning systems at all Red Cross branch levels. The trained Red Cross staff and volunteers located in flood-prone areas were on alert to be ready for the possible flooding and landslides.

When flooding occurred in Sinuiju city and Uiju county, over 350 Red Cross volunteers were mobilized for evacuation, research, rescue, first aid, distribution of relief items to flood victims and hygiene promotion among community people to prevent communicable disease in close cooperation and coordination with local authorities and other public organizations.

Upon receiving an emergency call on flood situation from the Sinuiju Red Cross branch on the morning of 21 August, DPRK Red Cross immediately dispatched the field assessment team headed by the executive vice-president to the flood affected area on the same day and released relief items for 2,500 families from the Sinuiju disaster preparedness regional warehouse on 23 August to support the affected communities.

On 15-17 May 2011, the operations coordinator from IFRC's Asia Pacific zone joined DPRK Red Cross and the IFRC DPRK country office to visit Sinuiju city to assess the timeliness, appropriateness and effectiveness of flood relief activities supported by IFRC and review lessons learnt in future operation under the discussion with Sinuiju city Red Cross branch and volunteers. The timeliness of the operation is much appreciated by the affected communities, whereas some support to the local Red Cross on how to communicate the selection criteria on beneficiaries with local counterparts would also benefit future operations.

Achievements against outcomes

The needs for supporting the flood-affected people in Sinuiju city were verified through field assessments conducted by Red Cross staff and volunteers and confirmed through coordination meetings with the government.

Relief distributions (food and basic non-food items)

DPRK Red Cross reached up to 2,500 displaced families (11,750 people) with 11,750 blankets, 2,500 cooking sets, 2,500 plastic sheets, 2,500 jerry cans and 1.2 million water purification tablets from the Sinuiju disaster preparedness regional warehouse. Taking into account the bad hygiene condition in flood affected areas, DPRK Red Cross also distributed 1,500 family hygiene kits and an additional 500,000 water purification tablets to affected families in Sinuiju city.

With the support of IFRC, emergency relief items like quilts, tarpaulins, cooking sets, jerry cans and family hygiene kits for 2,500 families were procured and replenished in the Sinuiju regional disaster preparedness warehouse in the following months.

A workshop to review the operation was conducted in May 2011, and general feedback from community leaders indicated that the timeliness of the operation was much appreciated by the affected communities.

Further feedback indicated that support to the local Red Cross on how to communicate the selection criteria on beneficiaries with local counterparts would also benefit future operations.

Challenges: During the period of July to September 2010, many areas in DPRK were hit severely by floods, landslides and storms. DPRK Red Cross, together with IFRC, released over 6,124 family emergency relief items to over 6,000 families (28,683 people) from its seven regional disaster preparedness warehouses. With the support of IFRC's DREF allocation, DPRK Red Cross replenished emergency relief items for 2,500 families. Unfortunately, as the National Society did not revise the DREF budget in early 2011, an opportunity was lost to replenish more emergency relief items through this DREF. An estimated 4,000 family emergency relief items like quilts, tarpaulins, cooking sets, jerry cans, water purification tablets and hygiene kits will still have to be replenished in future.

Water, sanitation and hygiene promotion

Outcome: provide safe water to over 16,000 displaced people for more than one month

Outputs (expected results)

Provide safe water to over 16,000 affected people for more than one month

Activities planned:

- Assess the existing coverage with a view of ensuring availability of an adequate water supply
- Provide safe drinking water through the operation and render hygiene promotion
- Conduct an ongoing assessment of the impact of the water and sanitation operation
- Conduct an impact evaluation

Assessments reported that the main water supply and treatment area were fully submerged and some parts of the water distribution pipeline were washed away. In response, DPRK Red Cross rapidly transported two mobile water treatment units to Sinuiju city and started to produce drinking water from the morning of 23 August. In total, 6.71 million litres of safe drinking water was delivered to schools where displaced people were staying, health institutions, public service facilities and flood affected communities, for approximately one month. Estimated total number of families reached through the delivery of safe drinking water is 28,000 families. The two mobile water treatment units were in operation for approximately six weeks until the water supply system to Sinuiju city was rehabilitated in mid-October. It was the first deployment of the water treatment units in response to a disaster since the equipment was handed over by the Spanish and Swedish Red Cross societies and training conducted in 2009 and 2010. Lessons learnt from the deployment will be incorporated into future trainings and response preparedness.

The hygiene promotion activities were carried out among displaced people and community people by mobilizing the trained Red Cross volunteers in close cooperation with local authority. In addition, the procurement of replacement parts and consumables for the mobile treatment units are underway. The items procured will help strengthen the National Society's preparedness and response to future disasters.
